## INTRODUCTION

Thank you for purchasing a Georgie Boy™ Recreational Vehicle. With your new Recreational Vehicle purchase, Georgie Boy provides a one-year Limited Base Warranty and a two-year Limited Structural Warranty. Also, many of our component suppliers offer warranties that extend beyond Georgie Boy's warranty coverage. In this guide you will find our Base and Structural Warranties along with a summary of the many component manufacturer warranties available to you. THE COMPONENT WARRANTY SUMMARIES ARE NOT INTENDED TO REPLACE THE COMPONENT WARRANTY DOCUMENTS PROVIDED WITH YOUR PURCHASE. Please refer to the original warranty documents when coverage questions arise. PLEASE REVIEW YOUR OWNER'S MANUAL FOR QUESTIONS REGARDING THE OPERATION OF YOUR RV.

### **FOR RECREATIONAL VEHICLES PURCHASED AND DELIVERED IN THE STATE OF CALIFORNIA AND WISCONSIN:**

Georgie Boy Manufacturing participates in the CAP-RV arbitration program operated by DeMars & Associates. This is a new program that is monitored by the respective states and the appropriate entities of those states certify that the program complies with applicable law.

(a) In California, the California Department of Consumer Affairs monitors the program. You must use it before claiming any rights conferred by 15 USC Sec. 2301 (Magnuson Moss Warranty Act) or California Civil Code Sec. 1793.22 (b) (Tanner Consumer Protection Act). However, you are not required to use the program if you choose to pursue claims not governed by those laws.

(b) In Wisconsin, the Wisconsin Division of Motor Vehicles monitors the program. You must use it before claiming any rights conferred by Wis. Stats Sec. 218.0171(7). You may choose to accept or reject the decision. Any waiver by a consumer of his rights under this section is void.

## GEORGIE BOY LIMITED WARRANTY

### Scope

The Georgie Boy Limited Warranty applies only to new recreational vehicles placed in service or sold by an authorized Georgie Boy™ dealer (“dealer”) for one-year from either the in-service date, original retail purchase date, or the first 15,000 miles of total use (“Warranty Period”) whichever occurs first. For the purposes of the warranty, “new recreational vehicle” does not include units used as demonstrator units (demos), used for commercial purposes, or any other “distressed” units of any kind (i.e. not purchased as new or sold as new by an authorized dealer) including; but, not limited to: units purchased from unauthorized dealers, through auction, through banks or financial institutions, units sold to the dealer “AS IS” with no warranty, or units used for promotional purposes. **Be sure you read and understand this Limited Warranty.** This Limited Warranty is transferable to a subsequent owner for the duration of the original period with proper application to Georgie Boy and a \$95 processing fee. Original owners must be properly registered with Georgie Boy within thirty (30) days of the first day of the Warranty Period to be considered for eligibility.

### Coverage

“Recreational Vehicle” (“RV”) means all portions of the product which are used or primarily maintained as a recreational vehicle and is not intended, nor manufactured, as a permanent residence, and excludes any components that are typically found in an automobile except the “Installed Portions”, which are those portions of the motorized product (if applicable) which were installed or attached to the chassis by Georgie Boy. These RV portions, which may also be described as “living facilities” include; but, are not limited to: the plumbing system, LP system, electrical systems unrelated to the propulsion of the vehicle, seals, flooring, cabinetry and other constructed wood components, and interior and exterior items designed and manufactured by Georgie Boy Manufacturing. In the event of a defect covered by this Limited Warranty, Georgie Boy at its sole discretion, reserves the right to substitute parts or components of substantially equal quality, repair the warrantable defect, or provide other such relief as deemed appropriate as the exclusive remedy under this Limited Warranty.

### Exclusions

THIS PRODUCT WAS DESIGNED AND IS INTENDED TO BE USED FOR RECREATIONAL OR SEASONAL USE ONLY. Your unit is a recreational vehicle and not intended, nor manufactured, as a permanent residence. No warranty is extended to recreational vehicles used for rental (unless the unit is maintained in accordance with a documented and bona fide inspection and maintenance program approved in writing by Georgie Boy), commercial, residential, or disaster relief purposes, or any purposes other than recreational travel and its intended use. All claims arising from such use are specifically excluded from any warranty coverage. Any unit used as a rental that is not registered with Georgie Boy as a rental within thirty (30) days of being placed in rental service is void of any and all warranties provided herein. Further, there is no warranty of any nature made by Georgie Boy beyond that contained in this Warranty. No person has authority to enlarge, amend or modify this Limited Warranty. The dealer is not Georgie Boy’s agent, but an independent entity. Georgie Boy is not responsible for any undertaking, representation or warranty made by any dealer or other person different from those expressly set forth in this Limited Warranty. This Limited Warranty is void in the event that you use the vehicle other than for its customary purpose, and/or fail to register and use the vehicle in one of the United States or Canada, and/or use the vehicle for commercial purposes.

Any claim or damage related to or caused by the following are specifically **EXCLUDED FROM COVERAGE IN THIS LIMITED WARRANTY:**

1. The automotive chassis or any components thereof which are warranted separately by the chassis manufacturer. This exclusion applies to; but, is not limited to: problems caused by or related to the engine, drive train, steering and handling, electrical system, fuel system, brake system, wheel balance or alignment, exhaust system, tires, batteries and gauges.
2. Components that are warranted separately by the component manufacturer. This exclusion applies to; but, is not limited to: generators, tires, batteries, and consumer electronics (televisions, DVD/VCR, stereos, radios, entertainment systems).
3. Improper or negligent use or operation of your RV or any component thereof;
4. Failure to maintain your RV in accordance with the Owner’s Manual and Maintenance Guide;
5. Overloading;
6. Abuse or misuse of any kind or type. For purposes of this Limited Warranty, misuse shall include; but, not limited to: commercial use including rentals without a regular and bona fide documented inspection and maintenance program approved in writing by Georgie Boy;
7. Collision;
8. The environment including; but, not limited to: rust, exposure to natural atmospheric elements, corrosion, ash or fumes, road hazards, rock chips or other road debris, flaking, peeling or discoloration of the exterior or finish;
9. Improper repairs;
10. Alterations;
11. Service calls of any kind;
12. Cosmetic flaws; including, but not limited to: scratches, bumps, minor imperfections (including paint), and incidental differences in measurement, or wrinkles, bubbles or seam print-through in any roof materials, which do not affect the use, value, or safety of the RV;
13. Adjustments to all exterior and interior doors and drawers beyond ninety (90) days from the first day of the warranty period;
14. Any upholstery damage including; but, not limited to: tears, punctures, misuse, or fading of fabrics or carpeting;
15. The failure to timely notify your Georgie Boy authorized dealer or Georgie Boy of any defect or problem. This specifically includes any increase in severity, magnification or exacerbation of any existing defect or problem;
16. Mold or mildew;
17. Formaldehyde or other noxious substances and/or fumes of any type;
18. Exterior paint or finish of your RV except for apparent application defects documented and communicated to Georgie Boy at the time of delivery and except for warranty coverage provisions provided through the manufacturer of the paint materials.
19. Chemical off-gassing of any type; and/or,
20. Aging of exterior fiberglass materials, including yellowing, curing, or surface stress cracks (or crazing).

### Limitation of Implied Warranties

**IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTY OF MERCHANTABILITY AND IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY DISCLAIMED OR LIMITED IN DURATION TO THE TERM OF THIS LIMITED WARRANTY.** Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

### Disclaimer of Consequential and Incidental Damages

THIS LIMITED WARRANTY EXPRESSLY EXCLUDES ALL CONSEQUENTIAL OR INCIDENTAL DAMAGES. This exclusion shall include; but, not be limited to: transporting the vehicle for service, lodging, meals, loss of use of the product, legal expenses, loss or damage to personal property, inconvenience or loss of income. In the event that such term is considered in any legal proceeding related to this Limited Warranty, any implied warranty or statutory right, “Days Out of Service” is defined as the number of days between the dates repairs are initiated and completion date less any days between those dates during which the RV was operable including; but, not limited to: part procurement time, service delays that are not the fault of Georgie Boy or any other delay in service during which the RV was operable.

### Entitlement to Attorneys Fees and Legal Expenses

In the event of any lawsuit or legal proceeding being filed by you or anyone on your behalf, the prevailing party in such a lawsuit shall be entitled to recover his/her/its attorney fees and legal expenses incurred in relation to the lawsuit up to a maximum recovery of such fees and expenses equal to twenty-five percent (25%) of the total retail cost of the unit. The determination of the “prevailing party” shall be made comparing any offers made by Georgie Boy to you prior to or during the pendency of the lawsuit, whether through final judgment, mediation or other form of settlement.

For warranty service, simply contact an authorized Georgie Boy Dealer or authorized Service Center for an appointment or consultation, and then take the vehicle (at your expense) to the servicing facility. It is the intent of Georgie Boy Manufacturing to satisfy our valued customers. If you have a problem obtaining satisfactory and timely warranty service that may substantially impair the use, value or safety of your Georgie Boy product, please call us on our toll free line (1-800-453-6064) so that we may attempt to resolve your concerns. Under the terms of this Limited Warranty, Georgie Boy reserves the right to perform warranty repair upon any alleged defects that may substantially impair the use, value or safety of your product at Georgie Boy’s manufacturing facilities or operated service centers with the customer responsible for all costs associated with transporting the unit to and from the facility.

## EXTENDED STRUCTURAL LIMITED WARRANTY

### Scope

The Georgie Boy Extended Structural Limited Warranty applies only to new recreational vehicles sold by an authorized Georgie Boy™ dealer (“dealer”) for two years from either the in-service date, original retail purchase date, or the first 25,000 miles of total use (“Warranty Period”) whichever occurs first. For the purposes of this warranty, “new recreational vehicle” does not include units used as demonstrator units (demos), used for commercial purposes, or any other “distressed” units of any kind (i.e. not purchased as new or sold as new by an authorized dealer) including; but, not limited to: units purchased from unauthorized dealers, through auction, through banks or financial institutions, units sold to the dealer “AS IS” with no warranty, or units used for promotional purposes. **Be sure you read and understand this Limited Warranty.** This warranty is not transferable to a subsequent owner.

### Coverage

The extended Structural Limited Warranty applies only to materials and components originally built or installed by Georgie Boy as described below. Provided that you notify Georgie Boy RV or one of its authorized servicing dealers of the defect in original materials or workmanship within the Warranty Period (two years or 25,000 miles), Georgie Boy Manufacturing will repair the exterior sidewalls, slide room walls, end walls (excluding front and rear caps), front wraps, floor structures and roof structures (excluding the exterior roof covering material) for all products, and the frame of any travel trailer or fifth wheel, free of charge for both material and labor, where necessary due to structural defects in original material or workmanship. Because of design changes, we may substitute parts or components of substantially equal quality.

### Exclusions

4. Delamination, disintegration or rotting of structural materials due to water intrusion from moldings, seals and structural connections that were not properly maintained (checked & resealed) on an annual basis;
5. Overloading;
6. Abuse or misuse of any kind or type. For purposes of this Limited Warranty, misuse shall include; but, not limited to: commercial use including rentals without a regular and bona fide documented inspection and maintenance program approved in writing by Georgie Boy;
7. Collision;

### Ford

#### Coverage

From warranty start date, 3 years or 36,000 miles, whichever occurs first. Five (5) years or 60,000 mile Powertrain warranty included.

#### Items Covered

Complete chassis except tires (covered by their manufacturer) and battery (covered by a separate warranty). After 12 months or 12,000 miles, “service adjustments” are not covered, which are minor repairs not generally associated with replacement parts, i.e., headlights, wheel balance, body panel and glass alignment, interior trim and upholstery adjustments.

#### Warranty Transfer

Ford’s warranty automatically transfers to subsequent owners providing the chassis is still within the established warranty period.

### **Tire Information**

All tires are covered by their respective manufacturer's warranties. In general, the warranty is for one year for full replacement, depending on tread wear; thereafter, the tires are pro-rated up to 2/32nd's of an inch and a term limit of 1 to 4 years. Please refer to the specific tire information in your owner's packet. Excessive wear due to alignment or improper maintenance is not warranted.

### **Batteries**

Batteries are also covered by their respective manufacturers. Usually, defective batteries are replaced on a pro-rated basis. Please refer to the Owner's Packet for warranty details and note the date stamps on the batteries so you are aware of any available coverage.

### **ASA Electronics (Jensen & Audiovox)**

ASA Electronics warrants to the original purchaser of the recreational vehicle ("RV") that Jensen and Audiovox consumer electronics (televisions, stereos, radios, entertainment centers) will be free from defects for two (2) years from the date of sale.
